Jr BBQ Cook-Off Rules and Guidelines

1.A contestant or team consists of one chief cook and no more than two assistants. Contestants may check into the barbecue cook-off grounds beginning Saturday June 1st at Noon, and must be in place by 1:00pm. You will be provided turnin trays at Saturday's Cook's meeting, scheduled for noon.

2. Junior Entry Fees are \$25.00 and covers all meat.

3. Any nudity, lewdness, or any form of vulgarity will NOT be allowed. No pyrotechnics, explosives or firearms are allowed. Any intentional use by the team will result in disqualification, and removal from fairgrounds.

4.Music within your team area is allowed. **HOWEVER**, NO excessive loud music and/or sounds which interfere with announcements, schedules, live bands and entertainment on stage, or which intrude upon or interfere with the comfort of fellow contestants.

5. Decisions of the Judges are final.

6. Two age group categories 8-12 and 13-17 will be judged accordingly

7. Trophies and cash will be given to 1st - 2nd and 3rd place only, (percentage based upon participation). Parents or guardians are allowed to supervise but cannot cook.

8.NOT APPLICABLE- All Jackpot category payout's: None this year

9. Damages/Security/Safety: Teams participating in the contest must not damage in any way the premises on which the contest is being conducted. UNDER NO CIRCUMSTANCES are there to be any stakes driven into the asphalt/concrete or any open fires on the grounds. All fires must be contained in a fireproof container. All drippings from BBQ pit must be contained. Please be sure to bag and dispose of properly. Security and safety are the sole responsibility of each team/contestant. The (Ingleside Smokin Jazz & Barbecue Cook-off) committee is not responsible for any injury to any such person(s).

10. Each team is responsible for ensuring that its space is cleaned following the contest. All trash must be placed in the dumpster provided. All flames and hot coals must be exterminated and disposed of properly. A team may be disqualified from further participation in the contest on any subsequent contest in the event that the team either causes damage to the grounds or leaves its space in disarray or with loose bundled trash or garbage following the contest.

11. In order to participate, check in for junior cooks will be at Noon under the basketball pavilion, at which time steaks will be given out with a cooks meeting. All steak must be cooked on site and turn in time will be 2:30pm. Prizes will be awarded under the Kiewit Tent along with the adult Barbecue Teams.

12. Sauce: You may COOK with sauce but DO NOT add sauce, marinade, or juice to the meat or container once the meat is prepared for turn-in.

13. Cooks are to prepare and cook barbecue in as sanitary a manner as possible. Cooking conditions are subject to inspection by the Committee. Conditions found to be unsanitary will be grounds for disqualification from the cook-off. At the present time Ingleside has a Burn Ban in effect and we ask for your cooperation in keeping our city safe. No holes, open fires, or dug pits will be allowed. However, a burn-down barrel will be allowed but MUST have some type of safety barrier placed across the top and around the sides of the barrel. Precautions MUST be made to prevent fire threat.

14. The Head Cook for each team will be responsible for the conduct of his team, guest, or invitees. As well, the Head Cook will be responsible for this team's compliance with the rules and regulations herein set forth. EXCESSIVE use of alcoholic beverages will be grounds for disqualification. Teams will not offer Barbecue FOR SALE. Any offensive conduct will be grounds for disqualification from the Cook-Off and expulsion from the Barbecue Cook-Off Grounds.
